A BILL

To preserve the cooperative, peaceful uses of space for the benefit of all humankind by prohibiting the basing of weapons in space and the use of weapons to destroy or damage objects in space that are in orbit, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Space Preservation Act
- 5 of 2003".

- 13 SEC. 6. SPACE-BASED NONWEAPONS ACTIVITIES.
- Nothing in this Act may be construed as prohibiting

- 17 (2) space research and development;
- 18 (3) testing, manufacturing, or production that
- is not related to space-based weapons or systems; or
- 20 (4) civil, commercial, or defense activities (in-

- are not related to space-based weapons or systems.
