GLOBAL NOTES AND STATEMENT OF LIMITATIONS, METHODOLOGY, AND DISCLAIMER REGARDING

DEBTORS' SCHEDULES AND STATEMENTS

The Schedules of Assets and Liabilities (the "Schedules") and Statements of Financial Affairs (the "Statements" and together with the Schedules, the "Schedules and Statements") filed by Primorsk International Shipping Limited ("Primorsk") and its affiliated debtors in these jointly administered chapter 11 cases (together with Primorsk, the "Debtors") pending in the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court") were prepared pursuant to section 521 of chapter 11 of title 11 of the United States Code (the "Bankruptcy Code") and rule 1007 of the Federal Rules of Bankruptcy Procedure by the Debtors' court-appointed advisors and Prisco (Singapore) Pte Ltd ("Prisco Singapore"), a non-Debtor affiliate who provides management services, and are unaudited. While the Debtors have made every reasonable effort to ensure that the Schedules and Statements are as accurate and complete as possible under the circumstances, based on information that was available to them at the time of preparation, subsequent information or discovery may result in material changes to these Schedules and Statements, and inadvertent errors or omissions may have occurred. Because the Schedules and Statements contain unaudited information, which is subject to further review, verification, and potential adjustment, there can be no assurance that these Schedules and Statements are complete. Furthermore, nothing contained in the Schedules and Statements shall constitute a waiver of rights with respect to these chapter 11 cases, including, but not limited to, the assumption or rejection of any contract, substantive consolidation of the Debtors, equitable subordination of any claim, and any of the Debtors' causes of action and/or related defenses.

The Schedules and Statements have been signed by Holly Felder Etlin, the Chief Restructuring Officer of Primorsk. Ms. Etlin assumed the role of Chief Restructuring Officer in January 2016. Accordingly, in reviewing and signing the Schedules and Statements, Ms. Etlin necessarily relied upon the efforts, statements, and representations of the Debtors' professionals and Prisco Singapore. Ms. Etlin has not (and could not have) personally verified the accuracy of each such statement and representation, including, for example, statements and representations concerning amounts owed to creditors, classification of such amounts, and their addresses.

These Global Notes and Statement of Limitations, Methodology, and Disclaimer Regarding the Debtors' Schedules and Statements (the "Global Notes") are incorporated by reference in, and comprise an integral part of, the Schedules and Statements, and should be referred to and considered in connection with any review of the Schedules and Statements. In the event of any inconsistency between the Global Notes and the Schedules and Statements, the Global Notes shall control and govern.

Description of the Cases

On January 15, 2016 (the "Petition Date"), Primorsk and nine subsidiaries filed voluntary petitions for chapter 11 with the Bankruptcy Court. The cases have been consolidated for the purpose of joint administration under case number 16-10073 (MG). The Debtors continue to operate their businesses and manage their properties as debtors-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

Basis of Presentation

The Debtors prepare consolidated financial statements in order to provide financial information to the shareholders of the Company and to its lenders. The consolidated financial statements are audited annually.

Because not all of the subsidiaries of Primorsk are Debtors in these chapter 11 cases, combining the assets and liabilities set forth in the Schedules and Statements of the Debtors would result in amounts that would be different from the financial information of Primorsk and its subsidiaries that would be prepared on a consolidated basis under International Financial Reporting Standards ("IFRS"). Therefore, these Schedules and Statements do not purport to represent financial statements prepared in accordance with IFRS nor are they intended to fully reconcile with financial statements previously prepared by the Debtors. Information contained in the Schedules and Statements has been derived from the Debtors' books and records and historical financial statements.

Due to the complexity and size of the Debtors' business, these financial books, records, and statements, and therefore these Schedules and Statements, could contain inadvertent inaccuracies, as well as classifications and characterizations which could result in the inclusion of an item on the Schedules and Statements of one Debtor that might be more appropriately reflected on the Schedules and Statements of another Debtor. The Debtors have made reasonable efforts to correctly quantify, characterize, classify, categorize, and designate the claims, assets, executory contracts, and other items reported in the Schedules and Statements. However, the Debtors may have inadvertently improperly quantified, characterized, classified, categorized, or designated certain items. In addition, certain items reported in the Schedules and Statements could be included in more than one category. In those instances, one category has been chosen to avoid duplication. Further, the designation of a category is not meant to be wholly inclusive or descriptive of the rights or obligations represented by such item. Moreover, the categories are included for ease of reference and are not controlling.

Amendment

Reasonable efforts have been made to prepare and file complete and accurate Schedules and Statements; however, inadvertent errors or omissions may exist. The Debtors reserve all rights to amend and/or supplement the Schedules and Statements from time to time as may be necessary and appropriate.

Confidential or Sensitive Information

There may be instances in which certain information in the Schedules and Statements has been intentionally redacted due to the nature of an agreement between a Debtor and a third party, concerns about the confidential or commercially sensitive nature of certain information, or concerns for the privacy of an individual. The redactions will be limited to only what is necessary to protect the Debtor or third party and will provide parties in interest who have a reasonable basis for review of such information with sufficient information to discern the nature of the listing.

Causes of Action

Despite their reasonable efforts to identify all known assets, the Debtors may not have listed all of their causes of action or potential causes of action against third parties as assets in their Schedules and Statements, including, but not limited to, avoidance actions arising under chapter 5 of the Bankruptcy Code and actions under other relevant non-bankruptcy laws to recover assets. The Debtors reserve all of their rights with respect to any claim, causes of action, or avoidance action they may have, and neither these Global Notes nor the Schedules and Statements shall be deemed to be a waiver of any such claim, causes of action, or avoidance action or in any way prejudice or impair the assertion of such claim, cause of action, or avoidance action.

Claim Description

Any failure to designate a claim in the Schedules and Statements as contingent, unliquidated or disputed does not constitute an admission by the Debtors that such claim or amount is not contingent, unliquidated, or disputed. The Debtors reserve all of their rights to dispute, or to assert a right of setoff or any other defense to, any claim reflected on their Schedules or Statements on any grounds, including, but not limited to, amount, liability, priority, status, or classification, or to otherwise subsequently designate any claim as contingent, unliquidated, or disputed.

Unliquidated and Undetermined Claim Amounts

Claim amounts that could not be readily quantified by the Debtors are scheduled as unliquidated or undetermined. Such descriptions are not intended to reflect the materiality of such amounts.

Effect of Payments Made Pursuant to "First Day" Orders

Pursuant to certain orders entered by the Bankruptcy Court in the Debtors' chapter 11 cases, the Debtors were authorized, but not directed, to pay, among other things, certain prepetition claims of employees, taxing authorities and critical vendors. Accordingly, these liabilities may have been or may be satisfied in accordance with such orders and therefore generally are not listed in the Schedules and Statements.

Dates

The information provided herein, except as otherwise noted, represents assets of the Debtors as of December 31, 2015 and the liabilities of the Debtors as of the close of business on January 14, 2016. December 31, 2015 was selected as the date chosen for asset data because it is the accounting closing date nearest to the Petition Date, and the net book values should not have changed materially between December 31, 2015 and January 14, 2016.

Bank account balances are as of the Petition Date.

Valuation

The Debtors' principal assets are their vessels. The vessels are shown at fair market value as of 12/31/2015, based on the average of two independent valuations. Amounts ultimately realized may vary from these values and such variance may be material. The valuations provided herein are not to be used and not intended to be used for any purpose other than for these Schedules and Statements. Accordingly, the Debtors reserve all of their rights to amend or adjust the value of each asset set forth herein for purposes of these Schedules and Statements.

Although liabilities are shown as of the Petition Date, the amounts shown exclude items identified as unknown or undetermined and, thus, ultimate liabilities may differ materially from those stated in the Schedules and Statements.

Specific Notes

These Global Notes are in addition to the specific notes set forth in the Schedules and Statements. The fact that the Debtors have prepared a specific note with respect to a particular Schedule or Statement and not as to others does not reflect and should not be interpreted as a decision by the Debtors to exclude the applicability of such specific note to any or all of the Debtors' remaining Schedules or Statements, as appropriate. Disclosure of information in a Schedule, a Statement, or an exhibit or attachment to a Schedule or Statement, even if incorrectly placed, shall be deemed to be disclosed in the correct Schedule, Statement, exhibit, or attachment.

Liabilities

The Debtors have sought to allocate liabilities between the prepetition and postpetition periods based on information and research that was conducted in connection with the preparation of the Schedules and Statements. As additional information becomes available and further research is conducted, the allocation of liabilities between prepetition and postpetition periods may change. The Debtors reserve the right to amend the Schedules and Statements as they deem appropriate in this regard.

Excluded Assets and Liabilities

The Debtors have excluded certain categories of assets and liabilities from the Schedules and Statements, including certain assets with a net book value of zero, general accrued liabilities, deferred revenue and accrued accounts payables. Other immaterial assets and liabilities may also have been excluded.

Interest in Subsidiaries and Affiliates

Primorsk owns directly all of the equity interests in the nine Debtor subsidiaries. In addition, Primorsk owns directly or indirectly all or part of certain other non-Debtor subsidiaries. The responses to Primorsk's Schedule A/B Question 15 and Statement Question 25 show its ownership interests, if any, in subsidiaries and affiliates and include ownership interests in partnerships and joint ventures. Assets such as investments in subsidiaries are listed as undetermined amounts as of the Petition Date because the book values may materially differ from fair market values.

Guaranties and Other Secondary Liability Claims

The Debtors have used reasonable efforts to identify guaranties and other secondary liability claims (collectively, "Guaranties") in each of their secured financings, debt instruments, and other such agreements. Guaranties related to debt instruments have been shown as liabilities for each Debtor and have been included in such Debtor's Schedule H. The Debtors reserve all of their rights to amend the Schedules to the extent that Guaranties have not been properly identified.

Co-Obligors

In the event that two or more Debtors are co-obligors with respect to a scheduled debt or guaranty, such debt or guaranty is listed in the Schedules and Statements of each such Debtor at the full amount of such potential claim, and such claim is marked "contingent" and "unliquidated." No claim set forth on the Schedules and Statements of any Debtor is intended to acknowledge claims of creditors that are otherwise satisfied or discharged by other Debtors.

Fiscal Year

Each Debtor's fiscal year ends on December 31.

Currency

All amounts are reflected in U.S. dollars.

Master Agreements

A number of contracts listed in the Schedules and Statements are master agreements that cover relationships with some or all of the Debtors. Where relevant, such agreements have been listed in the Schedules and Statements only on the Debtor(s) that executed the original or master agreement. In some instance the agreement may have been entered into by Prisco Singapore on behalf of one or more Debtor. Such agreements are listed on Primorsk's Schedules and Statements.

Insiders

The Debtors have attempted to include all payments made over the 12 months preceding the Petition Date to any individual or entity deemed an "insider". For these purposes, "insider" is defined to include (i) officers, directors, and anyone in control of a corporate the debtor and their relatives; (ii)general partners of a partnership debtor and their relatives; (iii) affiliates of the debtor and insiders of such affiliates; and (iv) any managing agent of the debtor. The listing of a party as an "insider", however, is not intended to be, nor shall be, construed as a legal characterization of such party as an insider and does not act as an admission of any fact, claim, right, or defense, and all such rights, claims, and defenses are hereby expressly reserved.

The Debtors' management services are provided by Prisco Singapore. The fees the Debtors owe to Prisco Singapore for such services were paid either directly by the Debtors to Prisco Singapore or by the Debtors to a third party as directed by Prisco Singapore. Question 4 of Part 2 of the Statements sets forth the various payments made by the Debtors to Prisco Singapore for such management services, including those payments made by the Debtors to a third party as agent for Prisco Singapore.

Payments

The Debtors participate in a substantially consolidated cash management system through which certain payments were made by Primorsk on behalf of another Debtor. As a result, certain payments listed in the Schedules and Statements may have been made prepetition by Primorsk on behalf of another Debtor through the operation of the consolidated cash management system.

Intercompany Transactions

The Debtors record intercompany receivables and payables generally related to charter income received and related expenses paid by Primorsk on behalf of the Debtor subsidiaries. Since all of the Debtors are obligated under the debt facilities, the respective Debtors intercompany accounts payable and receivable as of the Petition Date are not listed in the Schedules and Statements. However, intercompany accounts between Debtors and non-Debtor affiliates are reflected in either Schedule A/B or Schedule F.

Totals

All totals that are included in the Schedules and Statements represent totals of all known amounts included in the Schedules and Statements. The description of an amount as "unknown" or "undetermined" is not intended to reflect the materiality of such amount.

Schedule D

Secured Facility Loan Agreement means the loan agreement, dated as of January 2, 2008, among Primorsk, certain of Primorsk's subsidiaries, Nordea Bank Norge ASA, as agent and security trustee and the banks, financial institutions and other lenders party thereto, as such agreement may be amended from time to time. Swap Facility Loan Agreement means the secured loan agreement, dated as of June 7, 2011, among Primorsk, BNP Paribas, as facility agent, and the banks, financial institutions and other lenders party thereto, as such agreement may be amended from time to time.

The debt arising under or in connection with the senior term loan facility pursuant to the Secured Facility Loan Agreement ("Senior Secured Debt"), the junior revolving credit facility pursuant to the Senior Facility Loan Agreement ("Junior Secured Debt") and the Swap Facility Loan Agreement ("Swap Loan") are included in Schedule D.

Except as otherwise agreed to pursuant to a stipulation or an agreed order or pursuant to any other order entered by the Bankruptcy Court, the Debtors reserve their rights to dispute or challenge the validity, perfection or immunity from avoidance of any lien purported to be granted or perfected in any specific asset to a secured creditor listed on Schedule D of any Debtor. Moreover, although the Debtors may have scheduled claims of various creditors as secured claims, the Debtors reserve all rights to dispute or challenge the secured nature of any such creditor's claim or the characterization of the structure of any such transaction or any document or instrument related to such creditor's claim except as otherwise agreed to pursuant to a stipulation or an agreed order or pursuant to the any other order entered by the Bankruptcy Court. In certain instances, a Debtor may be a co-obligor or guarantor with respect to scheduled claims of other Debtors, and no claim set forth on Schedule D of any Debtor is intended to acknowledge claims of creditors that are otherwise satisfied or discharged by other entities. The descriptions provided in Schedule D are intended only as a summary. Reference to the applicable loan agreements and related documents is necessary for a complete description of the collateral and the nature, extent and priority of any liens. Nothing in the Global Notes or the Schedules and Statements shall be deemed a modification or interpretation of the terms of such agreements.

The Debtors reserve all of their rights to amend Schedule D to the extent that the Debtors determine that any claims associated with such agreements should be reported on Schedule D. Nothing herein shall be construed as an admission by the Debtor of the legal rights of the claimant or a waiver of the Debtors' rights to recharacterize or reclassify such claim or contract.

Schedule E/F

The Debtors are not aware of any outstanding priority claim amounts.

The Debtors have used their reasonable best efforts to list all nonpriority or general unsecured claims against the Debtors on Schedule E/F based upon the Debtors' existing books and records. Schedule E/F does not include certain deferred credits, deferred charges, deferred liabilities, accruals, or general reserves. Such amounts are general estimates of liabilities and do not represent specific claims as of the Petition Date.

The claims listed in Schedule E/F arose or were incurred on various dates. In certain instances, the date on which a claim arose is an open issue of fact. Determining the date upon which each claim in Schedule E/F was incurred or arose would be unduly burdensome and cost prohibitive and, therefore, in certain cases the Debtors do not list a date for each claim listed on Schedule E/F.

The Bankruptcy Court has authorized, but not directed, the Debtors to pay in the ordinary course of business and subject to specific terms and conditions certain outstanding prepetition claims. To the extent an unsecured claim has been paid or may be paid pursuant to these orders, such claim is not included on Schedule E/F. The Debtors reserve all of their rights to amend Schedules E/F.

Schedule E/F reflects the prepetition amounts owing to counterparties to executory contracts. Such prepetition amounts, however, may be paid in connection with the assumption, or assumption and assignment, of an executory contract or unexpired lease. In addition, Schedule E/F does not include rejection damage claims, if any, of the counterparties to the executory contracts that may be rejected.

The claims of individual creditors for, among other things, goods, services, or taxes listed on the Debtors' books and records may not reflect credits or allowances due from such creditors. The Debtors reserve all of their rights in respect of such credits or allowances. The dollar amounts listed may also be exclusive of contingent or unliquidated amounts.

Schedule G

While the Debtors' existing books, records, and financial systems have been relied upon to identify and schedule executory contracts of each of the Debtors, and although commercially reasonable efforts have been made to ensure the accuracy of Schedule G, inadvertent errors, omissions, or over-inclusions may have occurred. The Debtors do not make, and specifically disclaim, any representation or warranty as to the completeness or accuracy of the information set forth on Schedule G. The Debtors hereby reserve all of their rights to dispute the validity, status, or enforceability of any contract set forth in Schedule G and to amend or supplement Schedule G as necessary. The contracts listed on Schedule G may have expired or may have been modified, amended, or supplemented from time to time by various amendments, restatements, waivers, estoppel certificates, letters, memoranda, and other documents, instruments, and agreements that may not be listed therein.

The inclusion of a contract on Schedule G does not constitute an admission that such contract is an executory contract or unexpired lease. The Debtors reserve all of their rights with respect to the contracts listed on Schedule G, including the rights to dispute or challenge the characterization or the structure of any transaction document or instrument. Certain executory contracts may not have been memorialized and could be subject to dispute. Generally, executory contracts that are oral in nature have not been included on Schedule G.

The Debtors generally have not included on Schedule G any insurance policies, the premiums for which have been prepaid. In addition, the Debtors have entered into confidentiality agreements which, to the extent that such agreements constitute executory contracts, are not listed individually on Schedule G.
