Swift Energy Canada, Ltd. is a Canada domiciled corporation that was never capitalized. It has no assets or liabilities. This entity has de *minimis* (if any) value.

Swift Energy New Zealand Limited

Swift Energy New Zealand Limited is a New Zealand domiciled corporation. This entity conducted oil and gas operations until 2008 when it liquidated 100% of its assets except for a contingent royalty assignment. It will only receive future royalties if certain cumulative future production thresholds are achieved by the purchaser of its assets. Based on monitoring reports received by the Debtors, the probability of the production thresholds being achieved are remote. Accordingly, the contingent royalty rights are deemed to have no value. Swift Energy New Zealand, Ltd. has a \$65,000 intercompany liability to Debtor Swift Energy Operating, LLC for funds received to cover administrative costs of maintain New Zealand statutory compliance requirements. This entity has de *minimis* (if any) value.

Swift Energy New Zealand Holdings Limited

Swift Energy New Zealand Holdings Limited is a New Zealand domiciled corporation. This entity conducted oil and gas operations until 2008 when it liquidated 100% of its assets. This entity has no remaining assets or liabilities. This entity has de *minimis* (if any) value.
