STIPULATION AND AGREED ORDER BETWEEN THE DEBTORS, AMR CORPORATION, AND ACE AMERICAN INSURANCE COMPANY PROVIDING THE TERMS OF ASSUMPTION OF CERTAIN INSURANCE POLICIES AND AGREEMENTS PURSUANT TO A PLAN OF REORGANIZATION

AMR Corporation and its related debtors, as debtors and debtors in possession (collectively, the "**Debtors**" or "**American**") and ACE American Insurance Company, on behalf of itself and its affiliates (collectively, the "**ACE Companies**" and together with the Debtors, the "**Parties**"), by and through their respective undersigned counsel, hereby enter into this stipulation and agreed order (this "**Stipulation**") and stipulate as follows:

All capitalized terms shall have the meanings set forth in this Stipulation and, if not defined herein, such terms shall have the meanings ascribed to them in the Debtors' Second Amended Joint Chapter 11 Plan dated as of June 5, 2013 (ECF No. 8590) (the "Plan"). To the extent there are any inconsistencies between any plan confirmed in these Cases (as defined herein), any confirmation order entered in these Cases, and this Stipulation, the terms of this Stipulation shall govern.

RECITALS

- A. **WHEREAS,** on the Commencement Date, the Debtors filed their respective voluntary petitions for bankruptcy relief under the Bankruptcy Code in the Bankruptcy Court thereby commencing their bankruptcy cases (collectively, the "Cases"); and
- B. WHEREAS, the ACE Companies provide various forms of insurance and reinsurance to one or more of the Debtors or any of their affiliates or predecessors, including but not limited to general liability, workers' compensation, environmental, international, excess liability, and certain other insurance for specified policy periods (the "ACE Policies") subject to certain limits, deductibles, retentions, exclusions, terms and conditions as more particularly described therein; and
- C. **WHEREAS**, the ACE Policies include, but may not be limited to, the policies listed on **Exhibit A** hereto; and
- D. WHEREAS, in connection with and in addition to the ACE Policies, the ACE Companies have entered into numerous related agreements (including but not limited to, claims servicing agreements), documents or instruments related thereto (the "ACE Agreements" and together with the ACE Policies, the "ACE Policies and Agreements"), with one or more of the Debtors or any of their affiliates or predecessors; and
- E. **WHEREAS**, the ACE Agreements include, but may not be limited to, the agreements listed on **Exhibit B** hereto; and
- F. **WHEREAS**, the ACE Policies and Agreements remain in effect to the extent required by their terms and conditions; and

- G. WHEREAS, under the ACE Policies and Agreements, the ACE Companies have on-going and material obligations to the Debtors, and the Debtors have ongoing and material obligations to the ACE Companies; and
- H. **WHEREAS**, the following are representative examples of some of the continuing obligations of the Debtors under the ACE Polices and Agreements, although each obligation listed below is not necessarily due under each and every ACE Policy or ACE Agreement:
 - a. Payment of premiums;
 - b. Reimbursement of the ACE Companies for certain claims;
 - c. Provision and maintenance of collateral security;
 - d. Provision and maintenance of paid loss deposit funds and similar funds for payment of claims;
 - e. Cooperation in the investigation, administration, and settlement of claims in accordance with the terms of the relevant policies;
 - f. Defense of claims to the extent required by the terms of the relevant policies; and
 - g. Maintaining primary insurance coverage to the extent required by the terms of the relevant policies; and

- I. **WHEREAS**, the following are representative examples of some of the continuing obligations of the ACE Companies under the ACE Policies and Agreements, although each obligation listed below is not necessarily due under each and every ACE Policy or ACE Agreement:
 - a. Providing insurance coverage to the extent required by the terms of the relevant policies;
 - Paying covered claims to the extent required by and in accordance
 with the terms of the relevant policies; and
 - Defending the insured(s) to the extent required by and in accordance with the terms of the relevant policies; and
- J. WHEREAS, accordingly, each and every of the ACE Policies and Agreements listed on Exhibits A and B and as may be made applicable pursuant to Section 3.f hereof are deemed executory contracts for the purpose of assumption pursuant to this Stipulation and the Plan; and
- K. WHEREAS, on November 29, 2011 (the "Commencement Date"), each of the Debtors commenced a voluntary case under chapter 11 of title 11, United States Code (the "Bankruptcy Code"); and
- L. WHEREAS, also on November 29, 2011, the Debtors filed a Motion

 Pursuant to 11 U.S.C. §§ 105(a), 362(d), 363(b), and 503(b), (i) Authorizing, but not Directing,

 Debtors to (a) Continue their Insurance Programs, and (b) Pay All Insurance Obligations,

 (ii) Modifying the Automatic Stay with Respect to Workers' Compensation Claims, and

 (iii) Authorizing and Directing Financial Institutions to Honor and Process Related Checks and

Transfers (the "Insurance Motion") (ECF No. 18). In the Insurance Motion, the Debtors stated, among other things, that the continuation of their Insurance Programs (as defined in the Insurance Motion) and the payment of all undisputed prepetition and postpetition Insurance Obligations (as defined in the Insurance Motion) was essential to preserve the Debtors' business and preserve the value of the Debtors' estates for all creditors; and

- M. WHEREAS, on December 22, 2011, the Court issued a now-final order granting the Insurance Motion (the "Insurance Order") (ECF No. 429). Among other things, the Insurance Order authorized and empowered the Debtors to maintain their Insurance Programs without interruption and authorized the Debtors to pay all undisputed Insurance Obligations, including those that became due and payable before the Commencement Date; and
- N. **WHEREAS**, the ACE Companies, by and through counsel, filed the proofs of claims listed on **Exhibit C** hereto (collectively, the "**Proofs of Claim**") against the Debtors for claims related to the ACE Policies and Agreements; and
- O. **WHEREAS**, on May 10, 2013, the Court entered an order approving that certain agreement and plan of merger among AMR Corporation, AMR Merger Sub, Inc. and US Airways Group, dated February 13, 2013 (the "**Merger Agreement**"); and
- P. WHEREAS, on June 5, 2013, the Debtors filed the Plan and the Proposed Disclosure Statement for Debtors' Second Amended Joint Chapter 11 Plan (the "Disclosure Statement") (ECF No. 8591); and
- Q. **WHEREAS**, pursuant to section 8.3 of the Plan, the Debtors propose to assume certain contracts, including each and every of the ACE Policies and Agreements, and to

have the ACE Policies and Agreements be deemed assumed as of the Effective Date set forth in the Plan (the "Plan Effective Date"). (See Plan at § 8.3, and Disclosure Statement § IV.H.3); and

- R. **WHEREAS**, it is the intention of the Parties to set forth in greater detail herein the terms of the assumption of the ACE Policies and Agreements pursuant to the Plan. It is not the intention of the Parties to expand, increase, alter, or otherwise modify the terms and conditions of any of the ACE Policies and Agreements and/or the obligations under the ACE Policies and Agreements; and
- S. **WHEREAS**, based on the foregoing, the Parties have determined to consensually resolve this matter by entering into this Stipulation.

NOW, THEREFORE, IT IS STIPULATED AND AGREED, by and between the Parties that:

AGREEMENT

- 1. <u>Incorporation of Background Facts and Recitals.</u> The foregoing background facts and Recitals are incorporated herein as if set forth in full.
- 2. <u>Stipulation Effective Date.</u> This Stipulation shall be effective as of the date this Stipulation is so ordered by the Bankruptcy Court.
- 3. Terms of Assumption for the ACE Policies and Agreements. Pursuant to 11 U.S.C. §§ 105 and 365 and the orders of the Bankruptcy Court, the Debtors, to the extent one or more of them is a named insured, an additional insured, or an insured of any kind, individually

and collectively, and the ACE Companies, individually and collectively, subject to the terms of this Stipulation, hereby set forth the terms for the assumption of the ACE Policies and Agreements pursuant to the Plan.

- a. *Definition of Insurance Plans*. For the sole purpose of determining whether any of the ACE Policies and Agreements are Insurance Plans under section 1.134 of the Plan, Insurance Plans shall mean all insurance policies issued by any of the ACE Companies to one or more of the Debtors or any of their affiliates or predecessors and all agreements (including, but not limited to, claims servicing agreements), documents, or instruments relating thereto entered into between by such parties prior to the Plan Effective Date. For the avoidance of doubt, Insurance Plans shall include the ACE Policies and Agreements.
- b. *Definition of Workers' Compensation Plans*. For the sole purpose of determining whether an ACE Policy or an ACE Agreement is a Workers' Compensation Plan under section 1.251 of the Plan, Workers' Compensation Plan shall mean all of the Debtors' written contracts, agreements, agreements of indemnity, qualified self-insurance workers' compensation bonds, policies, programs, and plans for workers' compensation and workers' compensation insurance policies issued by any of the ACE Companies to one or more of the Debtors or any of their affiliates or predecessors and all agreements, documents, or instruments relating thereto entered into between by such parties prior to the Plan Effective Date. For the avoidance of doubt, Workers' Compensation Plans shall include such ACE Policies and related ACE Agreements to the extent that the applicable ACE Policy provides workers' compensation coverage or the applicable ACE Agreement

relates, in whole or in part, directly or indirectly, to workers' compensation coverage.

- c. Assumption of the ACE Policies and Agreements Pursuant to the Plan. Notwithstanding anything to the contrary in the Disclosure Statement, the Plan, the Plan Supplement, the Merger Agreement, the Confirmation Order, or any other order of the Bankruptcy Court (including, without limitation, any other provision that purports to be preemptory or supervening or grants an injunction or release), (i) each and every of the ACE Policies and Agreements shall be assumed by the Debtors pursuant to section 8.3 of the Plan, effective as of the Plan Effective Date, without any further notice to or action by any party or order of the Bankruptcy Court, (ii) after the Plan Effective Date, the Reorganized Debtors shall be liable for all of the Debtors' obligations and liabilities, whether now existing or hereafter arising, under the ACE Policies and Agreements which shall be paid in full in the ordinary course without the need or requirement for the insurers or third party administrators to file a Treatment Objection or otherwise object to the Proposed Cure Amount, (iii) any collateral or security securing the Debtors' obligations and liabilities under any ACE Policy or ACE Agreement shall continue to secure the Debtors' (or after the Plan Effective Date, the Reorganized Debtors') obligations and liabilities under the applicable ACE Policies and Agreements and (iv) nothing therein shall alter, amend or otherwise modify the terms and conditions of the ACE Policies and Agreements.
- d. *No Waiver of Causes of Actions*. Nothing in this Stipulation or in section 8.3 of the Plan shall constitute or be deemed a waiver of any cause of action that the

Debtors may hold against any of the ACE Companies, including without limitation any cause of action under any of the ACE Policies or Agreements; provided, however, that the Debtors, on behalf of themselves and their successors, release the ACE Companies for any claims arising under chapter 5 of the Bankruptcy Code effective upon assumption of the ACE Policies and Agreements on the Plan Effective Date.

- e. Withdrawal of Claims. In consideration of the assumption of the ACE Policies and Agreements on the Plan Effective Date, the Proofs of Claims automatically shall be deemed withdrawn on the Plan Effective Date without any further notice to or action by any party or order of the Bankruptcy Court.
- f. Addition of ACE Policies and ACE Agreements. The Parties hereto acknowledge and agree that this Stipulation shall apply comprehensively to all ACE Policies and ACE Agreements identified in the future that the Parties agree should be assumed and any such newly identified ACE Policies or ACE Agreements shall be added to **Exhibit A** or **Exhibit B**, as applicable.
- g. No Change in Contractual Rights. Except as expressly set forth herein, nothing in this Stipulation shall in any way directly or indirectly waive, impair, expand, or otherwise modify in any respect the legal, equitable, or contractual rights and defenses of the parties to the ACE Policies and Agreements under applicable non-bankruptcy law. By way of example and not of limitation, nothing in this Stipulation shall directly or indirectly expand the scope of insurance coverage available under any ACE Policy or ACE Agreement, increase the amount of

proceeds available under any ACE Policy or ACE Agreement, or increase the policy limits stated in any ACE Policy or ACE Agreement. The rights and obligations of the Parties to the ACE Policies and Agreements shall be determined solely by the terms and conditions of such policies and agreements, including any and all terms, conditions, limitations, exclusions, endorsements, and amendments thereof, which shall all remain in full force and effect as before the Commencement Date and under applicable non-bankruptcy law.

- h. No Change in Plan Executory Contract Assumption and Rejection Procedures.
 Except as expressly set forth herein, nothing in this Stipulation is intended to increase, expand, enhance, change, or otherwise alter the assumption and rejection procedures as set forth in the Plan.
- 4. <u>Governing Law.</u> This Stipulation shall be governed and construed in accordance with the laws of the State of New York.
- 5. <u>No Third Party Beneficiaries.</u> This Stipulation is for the sole benefit of the Parties, namely the Debtors and the ACE Companies. It is not intended to benefit any third person or entity who is not a party hereto, and thus no third party shall be able to claim to be a beneficiary hereof.
- 6. <u>No Modification.</u> This Stipulation may not be modified orally and may only be modified in a writing signed by all of the Parties hereto and approved by the Court.
