**STIPULATION REGARDING AGREED ORDER AUTHORIZING  
THE USE OF CASH COLLATERAL [DOCKET NO. 168]**

NOW COMES JASON R. SEARCY, the Chapter 11 Trustee (“Trustee”), THE PHILLIP M. POURCHOT REVOCABLE TRUST (the “POURCHOT TRUST”), and STARSIDE, LLC (“STARSIDE” and collectively with the POURCHOT TRUST, the “SECURED LENDERS”), and stipulate and agree as follows:

1. On November 25, 2013, an Agreed Order (a) Authorizing the Use of Cash Collateral; and (b) Determining Adequate Protection for, and Modifying the Automatic Stay as to, the Secured Lender (the “Cash Collateral Order”) [Docket No. 168] was entered into between the Trustee and the Secured Lenders.

2. Pursuant to the terms of Paragraph 47 of such Cash Collateral Order, the Trustee had a period of thirty (30) days to file an adversary proceeding or contested matter challenging the validity, unenforceability or priority of the Pre-Petition Obligations or the Secured Lenders’ liens on Pre-Petition Collateral in respect thereof, or otherwise assert any claims or causes of action against the Secured Lenders on behalf of the Debtor’s estate. Such thirty (30) day period of time expires on December 25, 2013.

3. The parties hereto agree to extend the Trustee’s timeframe set forth in Paragraph 47 of the Cash Collateral Order until January 31, 2014, and further stipulate such Trustee’s deadline to act under Paragraph 47 of the Cash Collateral Order is January 31, 2014.
