STIPULATION AND ORDER AUTHORIZING PAYMENT OF \$20,000.00 FROM THE ACCOUNT OF THE RECEIVER TO 38TH AVENUE REALTY LLC AS AN ADEQUATE PROTECTIOM PAYMENT

WHEREAS, on August 12, 2014 (the "<u>Petition Date</u>"), Shirokia Development LLC (the "<u>Debtor</u>") filed a voluntary petition for bankruptcy pursuant to Chapter 11 of Title 11 of the United States Code; and

WHEREAS, on October 8, 2014, 38th Avenue Realty LLC ("38th AR") filed proof of claim nos. 1 and 2, asserting a claim in the amount of \$16,797,590.31 and \$202,231.25, respectively, and secured by two mortgages on the Debtor's real property located at 142-28 38th Avenue, Flushing, NY 11354 (the "Property"); and

WHEREAS, since approximately April 1, 2011, Craig Zim, Esq. (the "<u>Receiver</u>") has been in possession of the Property as receiver pursuant to an order of the Supreme Court of the State of New York; and

WHEREAS, the Receiver is in possession of a bank account holding approximately \$26,545.94 as of August 20, 2014 in connection with his operation of the Property; and

WHEREAS, the Debtor has not made any post-petition adequate protection payments to the 38th AR;

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED THAT:

- 1. The Receiver is authorized to release \$20,000.00 to counsel for 38 AR.
- 2. The aforementioned payment will be deemed an adequate protection payment, which 38th AR shall apply to its allowed secured claim under 11 U.S.C. § 506.
