**DEBTOR'S AMENDED SCHEDULES OF ASSETS AND LIABILITIES  
AND AMENDED STATEMENT OF FINANCIAL AFFAIRS**

On April 26, 2015, PTC Seamless Tube Corp. f/k/a PTC Seamless Pipe Acquisition LLC (the "Debtor") filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101 *et seq.*, in the United States Bankruptcy Court for the Western District of Pennsylvania (the "Court"). On the same day, the Debtor filed its Schedules of Assets and Liabilities [Doc. No. 9] (collectively, the "Schedules") and its Statement of Financial Affairs [Doc. No. 8.] (the "Statement"). The Debtor hereby files amendments to the Schedules and the Statement as generally described below and more specifically set forth herein (the "Amendments"). The Amendments comprise an integral part of the Schedules and the Statement and should be referred to and considered in connection with any review of the Schedules and the Statement. The Amendments are incorporated fully into the Schedules and the Statement as if specifically set forth therein.

**Amended Schedule B.** The Debtor amended Schedule B to (i) include certain accounts receivable that were inadvertently omitted and (ii) amend the values reported for its interests in certain personal property to reflect the correct book values as of April 26, 2015.

**Amended Schedule D.** The Debtor amended Schedule D to adjust the value of property subject to liens so as to be consistent with the amended personal property values in Amended Schedule B.

**Amended Schedule E.** The Debtor amended Schedule E to adjust the claims of employees and former employees to account for (i) a mid-month wage advance that was paid to such employees and former employees in mid-April 2015 and (ii) accrued vacation for salaried employees and former employees.

**Amended Schedule F.** The Debtor amended Schedule F to (i) add existing and potential claims that were inadvertently omitted, (ii) exclude certain claims that were identified incorrectly as liabilities of the Debtor, and (iii) amend the value reported for certain claims to reflect the correct book value as of April 26, 2015.

**Amended Schedule G.** The Debtor amended Schedule G to include two unexpired leases with Pitney Bowes Inc. that were inadvertently omitted.

**Amended Statement Question 3b.** The Debtor amended its response to Question 3b to remove one check to Horizon Corporate Housing, LLC, which was never cashed, and to otherwise correct certain typographical errors.

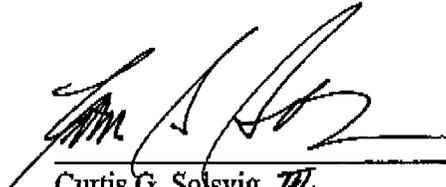
