

Rationale:

At the March 10, 2021, Board of Education meeting, the Elementary Task Force presented a revised Hybrid Instructional Model to be implemented at all MUSD elementary schools, when students and teachers return to campus. Some advantages of this proposed model of instruction include the ability to meet the social-emotional needs of students, while allowing them to move fluidly between inperson synchronous, and asynchronous lessons.

Background:

On February 25, 2021, the Elementary Task Force introduced a proposed hybrid model of instruction to the MUSD community to mixed reviews. At the March 2, 2021, Special Board of Education meeting, guided by the voices of MUSD parents, the Board of Education requested the Elementary Task Force revise the proposed plan to increase instructional hours to a full day of instruction, a minimum of 2 days per week. This revised Hybrid Instructional model is being proposed for implementation at all MUSD elementary schools.
